## Parenting Plans

The staff at By Peaceful Waters can lend their expertise and help alleviate pressure on lawyers and their time by creating and implementing Parenting Plans. Establishing a relationship with By Peaceful Waters staff helps to ensure that if conflict arises after the Parenting Plan has been implemented, the parents are more likely to return to them for coaching or coordination, avoiding further dividing their lawyers' time.



## Custody & Access Assessments (Section 30 Assessments)

An unbiased, third party assessment can be performed in cases where it has been difficult to establish a Parenting Plan, often due to conflicting perspectives on parenting and relational histories. The assessor will offer recommendations based on conversations with both parents, observations of the children, and interviews with professionals.



## Parenting Coordination

Parenting Coordination is a proactive approach to developing a parenting relationship in which conflict is dealt with quickly and with a focus on the health and well-being of the children in question. This process aims to equip parents with improved communication and problem-solving skills, with a goal of empowering them to implement these changes in their relationship without needing to regularly involve their lawyers or the court.

## Parenting Coaching

Parenting Coaching can help parents deal with issues as they arise, helping to implement solutions before the issues become significant conflicts. This process, which can be kept confidential, consists of sessions that can be booked on an as-needed basis. It helps to ensure the parents are not continually returning to their lawyers, and helps to keep them following the established Parenting Plan.



## Domestic Violence Screening

The professionals at By Peaceful Waters have undergone extensive training that uniquely qualifies them to screen for evidence of domestic violence and power imbalance. The screening report will normally recommend in favour of or against arbitration. It may also recommend arbitration if certain safeguards are put in place, such as that the parties not be left alone together or not arrive or depart together or that special procedures for giving evidence be used.
